Genie OPA Assembly Reinforcement

GIS has received a notice from OSHA that Genie has determined that the Operator's Protective Alarm (OPA) installed on any of the models listed on page 6 of the Safety Notice is equipped with a mounting bracket that may become loose. This may cause the OPA assembly to fall off the machine resulting in a collision hazard.

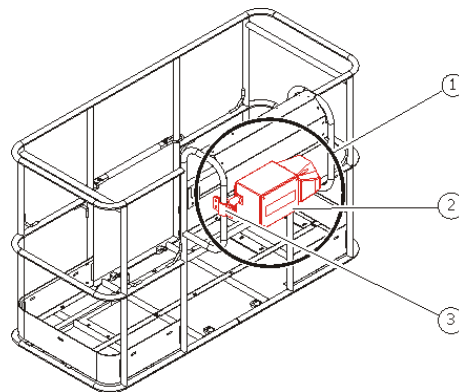


Illustration 1

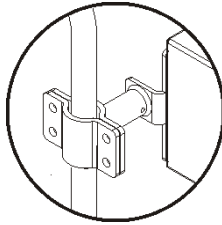


Illustration 2

Silver mounting bracket

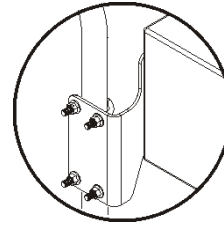


Illustration 3

- 4 Install the kit on the affected OPA assembly.

Continued Use Instructions:

All machine operators and users must be notified of these continued use requirements.

You may continue using the OPA assembly with the machine. However, the OPA assembly must be removed from the machine before transport. Re-install the OPA assembly at the worksite.

Note: Perform this procedure on a firm, level surface with the machine in the stowed position.

- 1 Locate the OPA harness connectors (items 1 and 2).

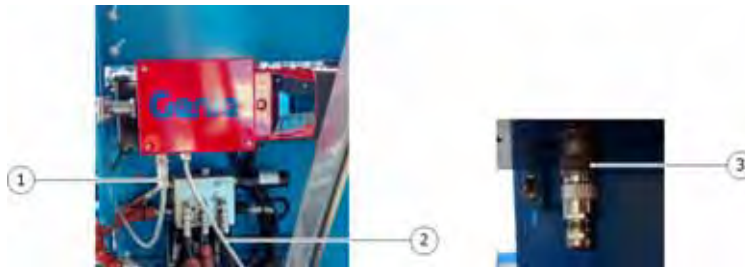

- 1 harness connector 1 (tape switch)
- 2 harness connector 2 (platform control box or footswitch)
- 3 blanking plug (Genie part number 1255030GT)

- 2 Disconnect harness connector 1 from the red OPA control box. Secure the harness.
- 3 Disconnect harness connector 2 from the platform control box or footswitch. Secure the harness.
- 4 Locate the blanking plug (Genie part number 1255030GT) from the machine document box and plug into the platform or footswitch connector where harness connector 2 was removed.

Note: The machine will not function if this connection is not plugged.

- 5 Disconnect the mounting bracket from the platform. Refer to illustrations 2 and 3 on page 2.

Note: Make sure to keep the mounting fasteners.

- 6 Set the red OPA control box on the platform and secure with a suitable tie down.

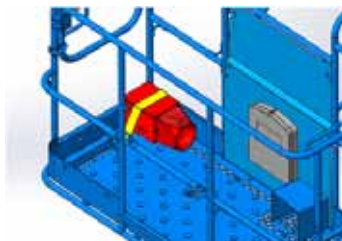
