GoM Medications Policy - Medication Responsibilities

All Medications must be in Original, labeled containers.

1. Includes prescribed medications, supplements, OTCs, etc.
2. If a medication is prescribed, you **MUST have a valid prescription**, i.e., *Testosterone can be purchased without a prescription over the internet, but it is a prescribed medication, and you MUST have a valid prescription from a licensed healthcare provider to bring offshore.*

Shipping medications

1. Boxes and containers are examined by heliport staff prior to sending offshore

GoM Drug and Alcohol Program - Heliport Drug & Alcohol Testing

Prohibited substances include cont.:

1. **Any otherwise legal but illicitly-used substances**, such as prescription drugs obtained or used without proper medical authorization (*this would include prescription drugs prescribed to someone other than the employee e.g., friends and family members*), over-the-counter drugs (including Dextromethorphan), **botanicals, plants, herbal supplements with mind-altering properties** (e.g., **Kratom, Salvia, Kava, Khat, Mescaline, Ayahuasca, Betel Nut**), **synthetic forms of illegal substances** (e.g., synthetic amphetamine-like substances, synthetic fentanyl analogs, etc.) and **other substances not being used for their intended purposes**; and
2. **CBD products** not included in Schedule 1 of the CSA (unless FDA approved). **Employees are on notice that CBD products may contain THC even if they claim otherwise.**

Random drug and alcohol testing at BP heliport for anyone going offshore (employees and contractors)

Special testing for TARs, projects, flotels, MODUs, vessels, hubs

1. For cause / Reasonable Suspicion
2. Qualifying Accidents and Incidents

Use of **drug dogs** may occur at BP heliport and offshore

Personnel and bag searches may occur at BP heliport and offshore

Cooperate and complete required random drug and alcohol testing and searches

Consequences for policy violation

Bed Bugs

Adult bed bugs, in general, are:

1. about the **size of an apple seed** (5-7 mm or 3/16 - 1/4 inch long);
2. **long and brown, with a flat, oval-shaped body (if not fed recently)**;
3. **balloon-like, reddish-brown, and more elongated (if fed recently)**;
4. a "true bug" (characteristics of true bugs include a beak with three segments; antenna that have four parts; wings that are not used for flying; and short, golden-colored hairs); and
5. smelly, with a "musty-sweetish" odor produced through glands on the lower side of the body
